## A LETTER FROM THE PASTOR

*<sup>12</sup> So now, O Israel, what does the LORD your God require of you? Only to fear the LORD your God, to walk in all his ways, to love him, to serve the LORD your God with all your heart and with all your soul, <sup>13</sup> and to keep the commandments of the LORD your God and his decrees that I am commanding you today, for your own well-being...<sup>17</sup> The LORD executes justice for the orphan and the widow, and who loves the strangers, providing them food and clothing. <sup>19</sup> You shall also love the stranger, for you were strangers in the land of Egypt. Deuteronomy 10:2-13, 17-19*

I have been thinking lately about expectations. The people of Israel were given the gift of God's law. The Ten Commandments and the other laws were God's expectations for the people of Israel as God's chosen people. The essence of these expectations is summed up here in chapter 10 of Deuteronomy: to love the LORD and to keep God's commandments. Loving God and keeping God's law had many applications, but one that gets mention over and over is **the special protection the people were to give the most vulnerable of society: the widow, the orphan, and the stranger.** In a society where women and children had no status or ability to own land or businesses, those unattached to a male to provide for them were in danger. Likewise, travelers and migrants were dependent on the hospitality of others, since there were no motels, YMCAs, or government assistance. A key benchmark for how faithfully the Israelites were keeping God's law was how they were treating these vulnerable people in their midst.

During the pandemic, we have had to adjust to many changes in expectations. Some of the expectations were mandated: government shutdowns, business protocols, quarantine requirements. Other expectations have been negotiated, such as who is in the 'pandemic pod,' whether you choose to shop or travel, choosing remote or in-person learning. As the dangers of the pandemic lessen, we once again negotiate changing expectations. The state of Connecticut has removed restrictions, and the CDC has stated that fully immunized people can remove their masks in many public settings.

I believe it is important as Christians to consider the responsibilities incumbent upon us from the government, but also the expectations of our faith. For while it may be safe for many of us to return to pre-pandemic habits, there are among us vulnerable people, as there were for the Israelites. We have people who are not yet eligible for immunization. We have (continued...)

(...continued) among us immunocompromised persons. We gather for public worship, where we welcome all comers, those we know, and those we do not know, those who are vaccinated and those who are not. **Our call as Christians is not to let these vulnerable people fend for themselves, but to be willing to prioritize their needs in order to create a space that is as safe as it can be for everyone.**

The Reopening Task Force and the Council are continuing to make appropriate adjustments to our practices and protocols for worship and gathering. We are returning to more 'normal' experiences. But we may be more conservative in our approach than some other communities and settings, out of our sense of Christian care for the needs of others. The Reopening Task Force and the Council will continue to communicate regularly with the congregation and encourage your questions and feedback.

A wise pastor once told me that a congregation's Christian faith is measured by how well they treat their homebound, their children, and visitors. I think the same is true for us. As we consider the needs of others, especially the most vulnerable in our midst, we express our love of God with all our heart and soul.

### **REOPENING TASK FORCE UPDATE**

The Reopening Task Force (RTF) is very pleased to announce next steps for expanding in-person worship and fellowship activities.

The State of Connecticut's latest guidance for religious gatherings, effective May 19<sup>th</sup>, 2021, has been relaxed for indoor and outdoor worship, allowing for numbers that can be "safely accommodated".

**Beginning on June 20<sup>th</sup> (Father's Day), the sanctuary will be open for 9 a.m. indoor Sunday worship.** Please register if you plan to attend as we have limited seating at this time.

For the time being, mask wearing and social distancing will still be expected for all over the age of 3 years who attend the in-person sanctuary service. We are taking this approach at this time to continue to ensure our more vulnerable populations, including the unvaccinated and children, are safe and protected. The Task Force will continue to assess this approach as all age categories become eligible for vaccination and recommend revisions to our protocols as needed.

Zoom services will be replaced once live streaming technology via YouTube is available. **St. Matthew will maintain its commitment to an ongoing virtual option for worship for those who prefer it or who cannot attend in-person.**

**Outdoor worship will be offered on Sunday mornings at 11 a.m. through June 13, and at 7pm on Wednesday evenings beginning June 24<sup>th</sup>, weather permitting.**

Mask wearing and social distancing are recommended but not required for fully vaccinated individuals for outdoor services and related outdoor Church activities. However we encourage all to wear masks as they arrive and leave to maximize the protection of all in our congregation.

Small group ministries and committees may now meet indoors and outdoors.

Masks will still be required for all indoor activities.

Please contact Diane at the office to reserve space in the building or outdoors.

The church building opened to the public on May 24<sup>th</sup>, 2021. The building is now open during office hours, Monday – Friday 9am – 4pm. Please ring the office doorbell for admittance if the door is locked.

The Reopening Task Force will continue to monitor the rapidly evolving guidance from CDC and State of Connecticut and will provide recommendations to Council as additional updates become warranted.





## **SUNDAY SCHOOL**




## **TUESDAYS TOGETHER**

**FINANCIAL HIGHLIGHTS****Operating Income:**

- Offering income was \$37K higher than budget YTD due primarily to prepayments of pledges (note the straight-line budget was adjusted in February to account for holdover pledges from 2020).
- The budget included a \$37,500 transfer from Endowment that we have not yet requested.
- Total YTD Operating Income was \$7.4K lower than budget as the higher income partially offset the lower money received from Endowment.

**Operating Expenses:**

- Total YTD Operating Expenses were \$1.7K lower than budget, with most categories being below budget.
- Compensation expense was higher than budget due to timing as the budget had May as a three-payroll month vs. April.
- Property was right on budget, with various line items better or worse due to the timing of expenses. We'll be requesting reimbursement from Endowment for the \$6.3K in HVAC expenses incurred year to date as this is part of their amounts set aside for internal distributions.
- The insurance premium for the property/liability renewal is slightly higher than budgeted amount. Workers' Compensation renewed at a slightly lower rate than budgeted.

**Net Operating Fund Activity:**

- Net Operating Activity was negative \$25K for the month and positive \$19.9K YTD vs. the budget of \$25.6K YTD, due to the items noted above. Note that net income would have been \$32K higher than budget had we requested and received the funds from Endowment. As noted above, this is due to the prepayment of pledges.

**Cash and Restricted Cash:**


- We continued to receive Capital Campaign contributions as people fulfill their pledges.
- The Endowment external contributions approved at the annual meeting were distributed in April, with the exception of \$5,000 for Grace Lutheran Church, which will be distributed for a specific project.

**Loans:**

- The balance of the loan from Endowment is \$12,454.60 at January 31st.
- We are working with People's to submit our application for PPP loan forgiveness and expect the full amount of the loan to be forgiven.
- We have determined that St. Matthew is not eligible to receive a grant under the second round of PPP loans.

**MARKETING & COMMUNICATIONS COMMITTEE UPDATE**

This will be a busy month with Reopening, Reuniting & Renewing! The Marketing and Communications Committee has some great things to share at our Reopening Celebration on June 20 at 10 a.m. Keep a look out for some exciting news!

**COUNCIL HIGHLIGHTS**

Our last Council meeting was filled with hope as we all explored ways to grow and expand who we are as a faith community. We talked about our "neighbors" and how we can experiment with a variety of ways to meet them. Music, service venues and even special projects were discussed.

Our discussions supported the theme of a recent sermon: "I am the vine, you are the branches, those who abide in me and I in them, bear much fruit." This also connects to the work that has been done with our marketing task force and our vision of digging deep, reaching out, changing lives.
